  - B. Library Operational Funds Report discussed no significant issues noted
- IV. Library Director's Reports
  - A. Director very disappointed to learn that the 5 year old HVAC control system has failed and needs to be updated/replaced. Other aspects of the report were discussed in detail. Russell Library (Middletown) leaving the LION consortium will almost certainly affect our LION fees and CCAR reimbursement in FY 2022.
  - B. Other
    - a. ARPA and Connectivity Grants ARPA grant approved. Should see monies in the very near future. Monies to be used to fund improvements in the children's room and other Covid-related improvements. Another grant opportunity (Connectivity Grant) is available. The intention is to apply for the Connectivity grant to continue the funding for the two wi-fi hotspots currently paid by PALS and additional fund two wi-fi enabled tablet computers. The director will go forward and submit this application.
    - b. Holiday Schedules Long discussion of public holidays and how the library should honor them. By closing? By having programs? There is the question of whether we need to be closed on all State/Federal holidays. Christine to come back with information and recommendations.
  - C. Year End Statistical Report discussed briefly. This is a very unusual year. It is hard to draw meaningful conclusions from the data.
